Key Points

- Roughly half of school parents are looking for additional support for their child's education this year, either from a learning 'pod' or tutoring. Parents with younger children (K-4), high incomes (\$75k +), and with a child enrolled in private schools or charter schools are most likely to be participating in learning pods or seeking out tutoring for their children.
- Parents report they are much more likely to participate in learning pods to supplement regular schooling and less likely to utilize pods as a substitute for regular school. But those who are "looking to form or join" a pod are twice as likely as current pod participants to seek them as an alternative to regular school.
- School parents are more concerned about their children contracting coronavirus at school since September. Half chose to enroll their children in remote/virtual learning over in-person classes this year. Parents also continue to be more favorable of and open to homeschooling in the future because of the coronavirus pandemic.
- School parents of children enrolled in private schools and charter schools rate their learning growth and development for this year higher than those with children enrolled in public district schools. Parents are more likely to prefer public district schools over private schools, charter schools, and homeschooling, but continue to have diverse schooling preferences.
- A slight majority of Americans believe teachers unions represent teachers' best interests. Those that agree that teachers unions have teachers' best interests believe unions are generally more helpful than harmful, believing they prioritize all teacher's interests. Those who see teachers unions as special interest advocates believe they do not prioritize students, schools, families, or the local community.

Methodology (also see slides 57-58)

This poll was conducted from October 12-29, 2020, among a national sample of 2,200 adults and an oversample of 700 school parents. The interviews were conducted online and the data were weighted to approximate a target sample of adults and school parents based on age, race/ethnicity, gender, educational attainment, and region.



Based on what you have seen, read, or heard so far, how would you rate the following institutions on their response to the coronavirus (COVID-19) outbreak?


















One or Multiple Learning Options Preference








Parents of children enrolled in private and charter schools score their child's learning and development progress this year higher than those with children enrolled in public district school.










Learning Pods







% Right Direction










Purpose of Education: High School














































Perception of Teachers Unions



To what extent do you feel that teachers unions are helpful or harmful toward...?







Methodology Update

Methodology Update

In addition to the monthly general population polling, Morning Consult has begun oversampling K-12 school parents, among a national sample of parents living in the United States (including the District of Columbia). The sample is collected via stratified sampling based on race and ethnicity quota targets derived from the U.S. Census Bureau's 2016 Current Population Survey. Approximately 700 additional K-12 school parents are interviewed in English each month comprising the oversample. The completed K-12 school parent interviews are weighted to population totals obtained from the 2016 Current Population Survey on the following demographic variables: age, gender, region, race/ethnicity, and educational attainment. Morning Consult has also implemented a pre-administration quota to ensure at least 70 percent of K-12 parent respondents had at least one child attending a public district school.


